#### ABSTRACT

The initiatives to improve the students' competency level is closely related to the quality of the lecturers. Lecturers play a very crucial role because they are responsible for teaching students of higher education institutions. A high-quality lecturer is believed to greatly influence their students' ability and competency. This study is to identify the level of lecturers' quality based on role-performance in teaching Mandarin in MARA Education Institutions (IPMA), specifically in Kolej Profesional MARA (KPM), Kolej Universiti Poly-Tech MARA (KUPTM) and Universiti Kuala Lumpur (UNIKL). There are five quality aspects of roles measured in this study: 1) lecturer as organiser, 2) lecturer as controller, 3) lecturer as a guide, 4) lecturer as a prompter and 5) lecturer as an evaluator. A total of 150 students from these institutions were selected, who have taken Mandarin as their elective language course. A Likert scale questionnaire is used to gather the data and SPSS software is used to statistically analyse the data. Based on the mean value interpretation, the findings revealed that the lecturers' quality on role-performance falls under a Very High level (M=4.63, SD=0.49) which simultaneously indicated that these Mandarin lecturers had the desired professional qualities and were committed to high quality teaching practice. These findings provide a better insight into the teaching of Mandarin in tertiary level education in Malaysia and in return can help to tailor professional learning activities to the professional development needs of lecturers.

Language anxiety is not a newly coined term and has been around for a long time. However, research that studies second language anxiety in online mode classes is still very limited. Therefore, this research intended to investigate the contributing factors towards KUPTM's TESL Undergraduates language anxiety and discover the coping strategies in dealing with such anxiety in an online learning environment. A mixed method study involving a survey and four (4) interviews was done. All 105 participants of this research were the students who were involved in online language learning. The data from the survey was analysed using IBM SPSS Statistic 25, while the interviews would support the quantitative findings through thematic analysis. The findings showed that the biggest factor that leads to language anxiety is the fear of negative evaluation, followed by the factor of distractions and the lack of a productive environment, and the third factor discovered from the data is communication apprehension. The coping strategies were divided into three domains; cognitive, affective and behavioural. It was found that the most used coping strategies by the participants of this research was behavioural. The results highlight a number of implications and recommendations for future researchers.

#### ABSTRACT

Dual Language Programme (DLP) refers to the use of English as a medium of instruction in the teaching of science and mathematics subjects in primary and secondary schools in Malaysia. It also an initiative programme to give students more contact to English language; thus, that will help improve develop English proficiency among students. The implementation of the program in a school is optional, which means the decision to have a DLP in a particular school is left to the school headmaster and parents, as parent groups played a critical role to bring back English as a medium of instruction in the national school system. However, one of main issues in the implementation of DLP is students' linguistic readiness to learn in English, particularly students in primary school. There are no clear guidelines on students' linguistic readiness in the selection criteria for admission to the programme. Thus, this study examines the readability of the textbooks used in primary school to understand the level of difficulty of the language. The preliminary study showed that a significant number of words and terminologies used in primary Year 1 science textbook are of Common European Framework of Reference for Languages (CEFR) B2 and higher, and this suggests the difficulty in learning science in terms of language. Hence, this study proposes is to generate a wordlist for science textbooks in DLP in primary schools based on CEFR readability difficulty levels. All units or topics from the science textbooks for each grade level (Year 1 to Year 6) were selected, processed and analysed. This paper discusses how the language used in science textbooks was analysed using the readability reference manager Text Inspector to generate the wordlist. Text Inspector is a web tool to measure the readability of the vocabulary based on the Lexis: EVP (English Vocabulary Profile) in accordance to the Common European Framework of Reference for Languages (CEFR). The findings highlight the sample list of words based on the CEFR readability levels of the science textbooks. The wordlist is beneficial to create the awareness and help science teachers to identify words that may pose difficulty for students to comprehend the lesson as well as in designing assessment tasks, and to those involved in textbook/learning material writing.

#### ABSTRACT

Home learning culture is vital to facilitate learning and education for indigenous students. Several attempts have been made to explore indigenous home learning culture in the overseas context; however, home learning culture, particularly among indigenous Semai primary school students in Perak, are still poorly understood. Previous studies conducted in Malaysia has indicated potential associations between the discrepancy of educational attainment of indigenous students and from the standpoint of schools and parents. This study was impeded by the lack of understanding of learning culturally from both individual and social context in the indigenous students' home. This research aimed to explore lived experiences on home learning culture among six indigenous Semai primary school students between the ages of 9-12 in Perak. The study was based on a phenomenological research design that included the application of photography, individual semi-structured interviews, focus group interviews and naturalistic observations for data collection and thematic qualitative analysis. The findings showed that learning formed and shaped in indigenous home learning environment was due to cultural norms and values, formal education values, and developmental and modernisation values. The findings can contribute to a better understanding of how and why indigenous students learn at home, and how home situations influence learning based on indigenous cultural norms and values through the shifts in formal institutional, developmental and technological conditions. This study, should therefore, be of value to school educators to embrace the learning experiences of indigenous students and be cognisant of the way they live, learn, and how they can be taught at home. It further provides insights to school educators to provide appropriate resources in response to their cultural, literacy and technological transformation to indicate home-school congruence.

#### ABSTRACT

IThis study aims to investigate the effectiveness of Trinka software in enhancing students writing quality among twenty two semester three students of Bachelor in Applied English Language of Kolej University Poly-Tech MARA Kuala Lumpur. The researchers collected students' first and revised drafts and the data were analysed using SPSS. The paired sample t-test revealed that there was a significant difference in the mean score of the first and revised drafts. This suggested that the students' writing quality improved upon getting feedback on their grammar errors from Trinka. The software is shown to assist students in reducing errors especially in language use (grammar) and mechanics of writing (spelling and punctuation). However, the improvement of students' writing quality cannot be directly attributed to the types of changes they made. The study further revealed that the students produced high percentage of Subject-Verb-Agreement errors in their writing. The data collected from the questionnaire also shows that the students in this study demonstrated positive attitudes towards the use of Trinka in the classroom. This research provides educators with an alternative assessment for students' writing that promotes autonomous learning.

#### ABSTRACT

Responding to student writing errors is a significant concern in ESL/EFL classrooms. Providing feedback is an essential task for teachers as corrective feedback can play a supportive and enabling role for students in improving their literacy skills. The current study looked into the aspects of writing that teachers pay attention to when providing written corrective feedback (WCF). The study relied on a survey questionnaire, interviews, and content analysis data. The study participants were 54 English teachers teaching ESL in high-performance schools in a West Malaysia state. All the teachers responded to a questionnaire, 8 teachers were interviewed, and 45 students' essays were analysed. The study's findings indicated that the teachers' preferences for the elements of writing in providing WCF were grammar (form), followed by vocabulary, mechanics, content, and organization, respectively. The results of this study suggest that providing corrective feedback (CF) focusing mainly on form can mislead students into thinking that grammatical accuracy is what 'good' writing is all about and which can cause students to lose sight of other significant elements of writing.

#### ABSTRACT

This study aims at evaluating the online classroom practices and its implementation as well as the impact of online teaching and learning from the student perspectives at Universiti Kuala Lumpur, Malaysian Institute of Marine Engineering Technology that enrolled in Engineering Science and Fundamental Thermodynamics courses. The analysis was carried out using the data collected through the questionnaire responses. Approximately 80% of bachelor students and just about 46% of diploma students like the approached during the online teaching and learning. This indicated that around 54% of diploma students preferred the conventional methods more. However, both bachelor and diploma students revealed that they were satisfied with the student-teacher interaction during the online teaching and learning with more than 90% agreed on this. The study also disclosed a positive feedback on the acceptance and usage of the online teaching and learning with around 78% of bachelor students throughout this new way of teaching and learning. The results from this survey may lead to the improvement of the online classroom execution for these two courses.

Higher education institutions have long been thought to be more vulnerable to the COVID-19 virus community spread, and nearly all schools and universities have abandoned face-to-face academic activities in favour of alternate teaching techniques. This quantitative study examines foundation students' self-regulated learning abilities and the extent to which self-regulation skills occur in the online learning context during the COVID-19 Pandemic. Self-regulation skills awareness is critical in foundation programme education. These abilities will prepare students to learn effectively in their future studies, especially in a blended learning environment in higher education. This study looked at six sub-constructs of self-regulated learning skills in the context of online learning, including goal-setting, environmental structuring, task methods, time management, help-seeking, and self-evaluation. Fifty foundation students from Universiti Kuala Lumpur MICET participated in this study. Most students reported using goal-setting, time management, environmental structuring, and help-seeking in an online learning environment. Overall, the findings showed that Foundation students' self-regulated learning skills were all above the midpoint of the fifty percent, except task techniques and self-evaluation, which are still minor. #### ABSTRACT

A successful education system emphasizes on producing all-rounders or holistic individuals. However, besides academic performance, little is known about developing other skills, namely non-cognitive skills in school. The current study employs a systematic literature review to determine the linkages between school climate with non-cognitive skills. Furthermore, three stages of systematic searching were performed for rigorous and systematic searching: identification, screening, and eligibility. The 52 articles included in this study were taken from Scopus, Web of Science and ScienceDirect as the leading databases, whereas Google Scholar and Dimension.ai as supporting databases. The keywords used include "school climate", "non-cognitive skills", and "student". Bronfenbrenner's Bioecological Theory of Human Development, Human Capital Theory and Developmental Systems Theory are the most prevailing theory that explains this phenomenon. #### ABSTRACT

The preparation and qualitative analysis of salts topic in the chemistry have constantly been recognized as one of the most challenging topics among the students and teachers. In Malaysia, many studies discussed the strategies to approach these topics to be more student-centered and engaging. However, there is a scarcity of studies focusing on learners' issues specifically related to these topics. Therefore, this paper focused on scrutinising learners' issues in learning the preparation and qualitative analysis of salts topic from teachers' perspectives. The researchers adopted a qualitative design and conducted semi-structured interviews with sixteen informants who have experienced teaching chemistry for more than five years selected via purposive sampling. The majority of them are either holding the title of excellent teachers or senior teachers in school. The study reports two themes that emerged from the interviews: the learners' perceptions and problems in learning the topics. The study results confirm the unanimity of past studies on students' unfavorable views on these topics as the informants frequently emphasized learners' criticisms on the difficulties of the topics, which comprises a high number of facts that require memorization. The learners also struggle with abstract concepts involved in the salts' formation and mostly have weak prior knowledge of salts, resulting in problems solving difficulties. The study suggested that teachers not simply practice various approaches and strategies that are deemed effective in aiding learners in learning of these topics but also be more selective in choosing approaches that are tailored to the individual students' needs in class, which more practical in providing them with an optimal learning experience.

This study aims to identify elements of flipped Malay language writing instruction framework for Form Two students in Malaysia. This study aims to determine the most appropriate free play activities based on STEAM education involving six strands from KSPK according to the expert's opinion. This study uses Fuzzy Delphi Technique. 20 experts were selected from Early Childhood Education, STEAM education, Science and Mathematics, Visual Arts Education, Physic and Language to analyses the Fuzzy Delphi questionnaire from Klang Valley, Tanjong Malim, Bukit Mertajam, Durian Daun and Kota Kinabalu. Findings of the Fuzzy Delphi Technique with experts indicate that all the experts have reached a consensus with the suggested 5 types of assessment for free play activities based on STEAM Education for preschoolers with experts' consensus of 99% (>75%). ## THE PERCEPTION ACCURACY OF ENGLISH MONOPHTHONG BY MALAY YOUNG LEARNERS IN MALAYSIA

#### ABSTRACT

Intelligibility is the ability to differentiate speech sounds and this ability is important in communication. Being intelligible is vital as perception accuracy is related to utterance understanding. Communicating in one's own native language may not be a problem, but the issue arises when one has to communicate in other languages, for example, English. The tsk to listen and at the same time, perceiving the correct message may be challenging. This present study investigates Malay young learners in Malaysia on their ability, in terms of accuracy, to differentiate three English monophthong pairs. Each monophthong pairs consist of one short and long vowel, which are / / - /i:/, / / - / :/ and / / - /u:/. Ten 11-year-old students who studied in a semi-urban primary school in Kuala Lumpur have participated in this study. The participants were selected carefully using a Language Profile Test, loosely based on Birdsong et al. (2012). They took parts in the two-alternative force-choice (2AFC) test, presented using PsychoPy software. The stimuli are presented in blocks and according to vowel pair, each targeted vowel was repeated three times. The findings reveal that the participants were able to distinguish the short and long vowels with 73.9% accuracy. Further analysis shows that the participants perceived / /-/u:/ better (98.3%) compared to / /-/i:/ (53.3%) and / /-/ :/ (70%). The participants performed better in distinguishing short vowels (75.6% accuracy) compared to long vowels (72.7% accuracy) and no significant difference was found (t (89) = -.555, p = .580). Overall, the participants were able to perceive and differentiate the targeted English monophthongs, which indicates that they have a high intelligibility score.

#### ABSTRACT

The bankruptcy rate among youth in Malaysia especially in Klang Valley is rising. The rise in the bankruptcy shows that youth in Malaysia has low financial literacy which result in financial distress, commonly bankruptcy. Despite the increase of bankruptcy cases among youth in Klang Valley, there is a dearth study on relationship between financial literacy and bankruptcy. The purpose of this paper is to study the relationship between level of financial literacy and bankruptcy rate among youth in Klang Valley. This paper also study the effect of financial literacy towards bankruptcy among youth, and to identify the concept of financial literacy from the definition and perception of youth in Klang Valley. It is proposed that youth with lower financial literacy has higher chance of bankruptcy. This research adopts quantitative method, utilizing questionnaire survey as the research instrument. #### ABSTRACT

There are many lessons that can be learned from the experience of Farmer Field School (FFS). FFS provides an opportunity for farmers to practice and monitor the sustainable use of agrobiodiversity through the adoption of new technologies that build upon their local traditions and cultural practices. Thus, this study aims to explore the paddy farmers' perceptions and experiences of agrobiodiversity-based rice farming practices in FFS participatory monitoring (PM) during the pandemic. The case study was conducted in three locations and involved nine farmers. The primary data were collected between October 2020 and March 2021 through interviews and observations. The findings showed that the perceptions of online and in-person PM methods and tools are equally important. The majority of farmers and trainers reported to perceive the use of digital applications like WhatsApp very effective in monitoring during and after the training activities. The use of digital tools supported the continued learning and facilitated the dissemination of information. Moreover, the local traditional and cultural practices also emerged as important elements in monitoring agrobiodiversity practices.

#### ABSTRACT

IThis study aims to investigate the effectiveness of Trinka software in enhancing students writing quality among twenty two semester three students of Bachelor in Applied English Language of Kolej University Poly-Tech MARA Kuala Lumpur. The researchers collected students' first and revised drafts and the data were analysed using SPSS. The paired sample t-test revealed that there was a significant difference in the mean score of the first and revised drafts. This suggested that the students' writing quality improved upon getting feedback on their grammar errors from Trinka. The software is shown to assist students in reducing errors especially in language use (grammar) and mechanics of writing (spelling and punctuation). However, the improvement of students' writing quality cannot be directly attributed to the types of changes they made. The study further revealed that the students produced high percentage of Subject-Verb-Agreement errors in their writing. The data collected from the questionnaire also shows that the students in this study demonstrated positive attitudes towards the use of Trinka in the classroom. This research provides educators with an alternative assessment for students' writing that promotes autonomous learning.

#### ABSTRACT

Family caregivers play a vital role in the lives of individuals with traumatic brain injury (TBI), especially during their rehabilitation and recovery. Having an individual in the family who suffers from TBI impacts the family system and contribute to major changes in their lives. This study employed qualitative research methods to analyse how caring for those with TBI impacts family caregivers. Data were collected using in-depth, one-on-one, semi-structured interviews with fifteen (15) family caregivers from Kelantan, Malaysia. Findings indicate that caregivers for family members with TBI experienced financial, social, psychological and physical impacts. Of these, only social impacts represented a positive outcome, as acts of caring strengthened bonds among family members. This finding may be unique to the Malaysian culture, where emphasis on family seems to buffer caregivers and those with TBI from the social isolation reported in studies conducted in western contexts. The research suggests that family caregivers need ample support, especially from governmental and non-governmental organisations, to ease their burden in caring for family members with TBI.

In Malaysia, there is a lack of published articles regarding spinal cord injury (SCI) and the roles played by social workers. Such information is important as SCI can affect the quality of life of the individual who experiences it. The purpose of the study was to explore the challenges faced by SCI patients and to find out more the relationship between SCI and social workers so as to enhance the quality of life of SCI patients. #### ABSTRACT

The 14th Malaysian General Elections (GE14) result has proven to be a good platform of democracy after the opposition coalition party successfully topple down the ruling coalition party since the first election. This paper discusses a survey conducted within four days before GE14 nomination day announcement to measure the voters' views and interest. The main two objectives are (i) to measure the voters' preference of candidates' characteristics; (ii) to examine the issues that are concerned by the voters; and (iii) to discuss voting inclination before GE14. The methodology used is a cross-sectional survey conducted from 24 April until 25 April 2018 using Google survey and distributed through WhatsApp and Facebook. This survey received an overwhelming response and managed to gather 1331 respondents. The survey has 21 items in four sections – demography, candidate characteristics, issues, and opinion on Malaysian politics. The findings portray that candidate characteristics have slightly changed from party-based voting to candidate personality.

This study is an initial exploration into the Klang Valley business organisations' awareness on green management practices i.e. energy and water savings and reduce, recycle and reuse (3R) habits. This is a quantitative study conducted on business organisations in Klang Valley. #### ABSTRACT

The Government of Malaysia has introduced the work from home (WFH) policy in 2020 due to the alarming attack of the Covid-19 virus globally that change the working environment in adapting to the new norms. This policy has outlined the guidance on how WFH should be implemented by the public sectors workers in Malaysia as a tool to serve the people. Being the biggest composition of public sectors workers in Malaysia, the females who are more likely to favouring WFH are also having harder time of doing so taking into consideration the surrounding factors which end up affecting their job motivation. Thus, this study intends to examine factors that affect job motivation among female workers in public sectors in Malaysia during the implementation of the WFH policy. This study adopts a descriptive survey research design. The research sample are 150 female workers from Majlis Amanah Rakyat (MARA), the biggest public agency under the Ministry of Rural Development. The sampling technique is a single-stage random sampling technique using the Likert scale. Four (4) instruments are used for this study namely: work-life balance, management support, job stress and job motivation scales synchronized into a questionnaire. ## ABSTRACT

Today, the Internet world is burdened with various threats, where is generated by attackers all over the world. One of the Internet threats is DDoS attacks. DDoS attacks can deny access made by anyone, including authorised users, to a system. There are several types of DDoS attacks that an attacker can generate. They include UDP flood, HTTP flood, Slowloris, TCP SYN flood and ICMP flood. This paper is prepared to propose a technique to detect packets, whether normal packets or DDoS attacks. This technique is called Packet Threshold Algorithm (PTA), where it is combined with several machine learning techniques for packet classification. The PTA is coupled with Support Vector Machine (PTA-SVM), K-Nearest Neighbor (PTA-KNN), Logistic Regression (PTA-LR) and Naïve Bayes (PTA-NB). The combination of these techniques is able to distinguish five packets that have been generated. They are normal packet, Ping of Death, TCP SYN flood, Smurf and UDP flood. All techniques were tested to look at detection accuracy and false-positive rate. Thus, our study found that PTA-KNN is the best technique based on the achievement of 99.83% detection accuracy with a 0.02% false-positive rate compared to the achievement of the other three techniques.

Performance of the vibration responses of a structure dependent on the accuracy of the input properties values of the developed FE model. The initial FE results computed are often found not replicate well with the experiment due to the simplification of input parameters of the FE modelling. The deterministic reconciliation method of modal based updating can be used to alter the uncertain initial properties of the base model of the structure systematically. The design sensitivity is utilised to identify the potential parameters to responses to be used as the updating parameters. To evaluate the performance of the developed scheme, the base and the updated natural frequencies and mode shapes computed are compared with experimental results. The results showed percentage of error is 35.36 per cent from the initial model and the error of the improved model significantly reduced to 8.27 per cent. In conclusion, the modal based updating has been successfully reduced the discrepancy of initial FE model and the experiment result. Subsequently, the updated FE model can be used for further structural analysis with more confidence.

Thus, to evaluate the perceived effectiveness of SAMBLE system, a survey was conducted with the participation of 32 lecturers and 108 students of Kolej Universiti Poly-Tech MARA (KUPTM). Respondents were selected using purposive sampling and the statistical method used is a descriptive analysis. The system was evaluated based on its functionality and usability test. The results showed that the SAMBLE system is perceivably effective in assisting lecturers to record attendance, manage class schedules and student attendance as well as to assist faculty in monitoring students' absenteeism effectively. Diffusion Bonding (DB) or also can be called as Diffusion Welding (DW) is a solid-state bonding process. Tensile strength of the welds was significantly affected by three (3) different parameters which are Bonding Temperature, Bonding Pressure and Bonding Holding Time. Although, some other parameters also affected the quality and strength of the weld joint, but these parameters are the main that need to be focused. It is vital to enhance cost reductions in today's competitive transport and logistics company. One technique is to be joining different materials as elements of vehicle components. Joining of dissimilar materials may cause defects. Using this welding process, it can be applied in the small boatbuilding and somehow, this method already been applied in aerospace industries which can gives a good advantage in saving cost and times.
